Medical Staff Briefing – Dr. Mark Peterson, NSHC Medical Director	 Dr. Peterson gave medical staff update on the following: Alaska: 4 cases from yesterday, 38 active cases We are going to continue to see a smoldering of cases and hopefully not a big spike Deanna gave an update for Alaska: in the last 24 hour reporting period we have had 1 new case, up to 388 cases, 343 recovered, increase in hospitalization and now at total or cumulative of 41 hospitalization, currently 8 individual who have COVID-19 or a suspect that are admitted in the hospital ANMC: 2 new patient in the hospital with COVID-19, one of the first inpatient in the state, haven't had one since than until now We expected this NSHC: no additional positives, close to 1,300 individual test, over 1,700 test, tested about 12% in region, Tent is open Monday – Friday 8am – 5 pm now, next weekend will have limited weekend hours in the afternoon and will update next week Dental patients who are coming in for dental will have to have a test Continue doing what you are doing: Social distance, washing hands, masks, being careful, being cautious, people should be able to have fun over the summer, but also be careful and cautious Hopefully the state will continue to test aggressively, and we are going to continue to test aggressively and watch for any new cases

	 other things that tribal health can work on to keep medical travelers safe going into Anchorage One issue that Tribal Health will help work on is creating our own wing at the airport, maybe the B wing, or I think we really need segment flights that are coming in from the lower 48 with flights that are in state between our hub and rural communities to reduce contact opportunities between labor's coming up from the lower 48 for the oil and fish communities with our medical travelers coming into Anchorage Feel that there is a sense in the air that there were no people wearing mask, think people are becoming fearless, and think they don't know of our own sensitives and vulnerability in this state

Question and Comments	 Question for Diomede: People traveling in region no longer have to quarantine in Nome, only if they are coming from Anchorage or outside communities? We will find out more once they get information from Pathfinder and hold a city meeting. They will let Amy know. Recommendation was made that NSEDC and fish and Game should have a meeting with the fisherman in regarding to commercial fishing. Will make sure it happens next week. There has been asked to have a special meeting just related to fishing. There's the commercial side of it but there is also general subsistence, families going out, we reference

pilgrim river, seining for reds, the volume that gets together to participate in that. We wanted to have one meeting that focuses on that. We will get with the right people and try to coordinate something that folks can call into and thank you for that reminder.

- Young people with Kawasaki syndrome having an adverse impact on the young people. I wondering how well we are versed on the issues?
 - Dr. P: Kawasaki disease has been around for a long time and is an inflammatory disorder. It's quiet rare but does happen. The children who develop this inflammatory disorder related to COVID-19 have COVID-19. They have to get COVID-19 and have it and after they have it there is a very small chance they can develop this inflammatory disease. It's more of a concern in those states that are having 10,000+ cases of COVID-19 where some children are getting it. In our state we have had over 300 cases, not sure how many are children, but not very many of them. Those children who have developed COVID-19 it would be a very small number that would be at risk. The medical staff is aware of that and we do share that and have gotten the CDC update about that and we are on the lookout for it. As these alerts come in Medical Staff reads them, shares them, and become prepared, and think about them. It would be unusual for us to get a case like that in our region now because case numbers are low. It is something that is out there that we need to be watchful.
- Deanna Stang will forward fisheries employee agreement, operation plan, safety plan, and checklist that out sources have created in partnership with some of the fishing industries across the state.
- What soaps or cleaning products should we not mix with Clorox?
 - Avoid mixing any chemicals. Use one at a time per manufactures instructions.
 - MAS: Usually opens window. It is always good to have good ventilation.
- Are patient travelers able to bring liquid and spray hand sanitizers onto the airplane?
 - There is guidance on the TSA website. Encourages patients to keep them to 3 oz or less.
 - Would be really good for our hospital travelers as well. Maybe Health Aides can post something up.
 - We can add that to our travel education that we are going to put together.
 - Another suggestion is using the package wipes when traveling.
- Comment was made and was thanking the crew that provided services. Very grateful for this conference.
- The two new cases are they travel related?
 - It was not listed where Dr. Peterson could see.
 - Deanna: There was one reported case yesterday and it has not been reported. The DHSS press release should be coming out later this afternoon and they'll indicate where the community is and give some other demographic like the age range. They have not been recently

publishing on the DHSS press release whether or not it is community
related or travel related. Also wanted to make a clarification that
yesterday someone may have asked about the cases, about 4 new cases.
Those were actually 3 in Anchorage and 1 in Tok and none in Juneau.
Those cases were reported May 14 th .
• Comment was made that hospitals have been financial hit due to COVID-19
and appreciate NSHC approach and also appreciate these daily calls.
• Angie: NSHC is extremely blessed. We were not hit as hard as some of
the other tribal health organizations or hospitals. Not only in our state
but everywhere and again we are fortunate that finances and the fiscal
situation was good at Norton Sound. For the month of April we will see
a loss. May, might look a little better as we open up. Just thankful we
did not have to furlough or layoff or make really tough employee
discussions. All of our employees continue to receive a paycheck. We
were even able to allow folks that were still working their normal
schedule, while others were taking time away to help promote social
distancing, the folks that were here every day were able to accrual time
that they could use at another time this summer as things stabilize.
Again we are opening very slowly. We are still encouraging patients, if
they are scared to come in the facility that we know our facility is safe.
We are cleaning, were taking extreme precaution with our employees
and are moving to mandatory testing corporate wide for direct patient
care staff on Monday. For those who are still able to stay at home and
connect with your provider through telemedicine at your computer that
would be suggested and recommended. If you are at the age group of
65 years of age or older or immunocompromised meaning you have
some underlying health condition we want you to take extra precaution
and that hunkering down and staying home is still a very important
thing to do. Norton Sound continues to reach out to you since staying
home is easier for you.
